12 OPTION K (PAYPHONE, INSTITUTIONAL & LEC CALLING CARD)

The following rates apply to calls made with the assistance of an operator from MCI presubscribed public, semi-public, or private payphones, and from MCI presubscribed institutional phones, or with a Local Exchange Company calling card. These rates also apply to calls made from phones not presubscribed to MCI via an MCI carrier access code i.e. 1010222, from non-MCI presubscribed (T) phones. In addition, Service Charges apply, as indicated. No volume discounts are applicable to calls made under this service nor is the usage or surcharge revenue included in the calculation of any discount eligibility. The surcharges listed below are subject to Friends & Family discounts when imposed on calls which are eligible for that program. If the computed charge includes a fraction of a cent, the fraction is rounded down to the next whole cent.
